### **About the Exhibition**

Lyme Art Association member artists of all levels may submit up to four (4) works of art in any theme to this juried exhibition. All work must be representational, and paintings, drawings, hand-pulled prints and sculpture are eligible.

**Exhibition Dates:** August 9 – September 20, 2018

**Receiving:** Saturday, August 3 and Sunday, August 4, 10am – 5pm.

**Open to:** All LAA members

**Individual & Associate Artist Submission Fee:** \$20 for 1<sup>st</sup> piece, \$10 for each addition, up to four.

**Elected Artist Submission Fee:** \$25 for up to four pieces.

**Juror:** TBD

**Acceptance notification:** [www.lymeartassociation.org](http://www.lymeartassociation.org) on August 6, by 5pm.

**Removal of unselected work:** August 9-September 20 during gallery hours, Wed. thru Sun. 10am – 5pm, but not during opening reception.

**On View Date:** Friday, August, 9.

**Reception & Awards Date:** Friday, August 16, 5 – 7 pm. Reception is open to artists and public.

**Removal Date:** Saturday & Sunday, Sept. 21 & 22, 10 – 5pm.

### **AWARDS**

All participants are eligible for the following awards:

1<sup>st</sup> Prize - **\$500**

2<sup>nd</sup> Prize - **\$250**

3<sup>rd</sup> Prize - **\$125**

People's Choice - **\$100**

### **Entry Requirements**

- All work must be for sale, be framed or gallery wrapped, signed on front or back, and wired for hanging.
- Work for this exhibition must have been created in the last 3 years.
- Work must not have been shown at the LAA in any previous juried exhibition.
- All work will be juried with no guarantees. Decisions by the juror are final.
- Photographs, off-set lithographs, and prints made using xerographic, digital, or photographic processes do not qualify.
- Work that is done under tutelage (while in a class or workshop) may not be submitted.
- **PLEASE, NO WET PAINTINGS!**
- **All submissions of work and materials are at the artist's sole risk. The LAA assumes no responsibility for loss or damage during the exhibition or subsequent storage at the close of the show. Artists agree to commit accepted works for the duration of the exhibition. The LAA reserves the right to remove or not accept any art for any reason at any time.**
- **Artwork left for more than 90 days after the exhibition closes will become the property of the LAA.**
- **The entry of your artwork constitutes your acceptance of these terms.**

**TERMS AND CONDITIONS FOR SALE OF ARTWORK:** Checks and credit card payment for purchase of artwork, including CT sales tax, shall be made out to the LAA. **If the artwork is sold, 35% of the sale price will be retained by the LAA and 65% of the sale price will be remitted to the artist by check from the LAA.** The LAA will retain and remit the sales tax. As a not-for-profit organization, the LAA provides the artists with an opportunity to exhibit but does not assume the role of agent or representative.
